SCHEDULE “A”
ARMDALE YACHT CLUB LEARN TO SAIL PROGRAM
FAMILY & “BUBBLE” SAILING
COVID-19 POLICY

We are pleased to offer the Armdale Yacht Club’s Learn to Sail Program (the “Program”) this year. Due to COVID-19 and public health requirements, we have put forward the following measures and policy to ensure a safe learning environment for all participants to ensure compliance with public health guidelines. The following Policy is based upon Sail Canada’s guidelines and those approved by Sail Nova Scotia. **By agreeing to register for the Program, you agree to the Terms as outlined in this Policy:**

1. **CLASS SIZES** Our class sizes (both on-water and in-class) will be limited to six (6) students and one to two (1-2) instructors per session.
2. **PERSONAL FLOTATION DEVICES (“PFDs”)** Every participant in the Program must supply his or her own PFD that is DOT approved. AYC will not offer storage of PFDs outside of sessions, and all participants must bring their PFD to each on-water lesson and take it home with them when leaving.
3. **IN-CLASS SESSIONS** AYC’s Sail Training Facility will be arranged so that participants will be kept 2 metres / 6 feet apart during all in-class sessions. Participants agree to ensure that these distances are kept at all times when interacting with other participants.
4. **FLOOR MARKINGS & PHYSICAL SPACING** AYC will indicate safe distancing among participants on docks, ramps, and within the Sail Training Facility using floor markings and other indicators. All participants agree to act in compliance with these indicators, and **any participant who acts in flagrant disregard of such measures may be removed from the Program** and refunded the balance of his or her registration fees in AYC’s sole and absolute discretion;
5. **SURFACES** AYC will ensure that all touch surfaces in the Sail Training Facility and on the boats are disinfected after each lesson. AYC will follow Sail Nova Scotia’s recommendations regarding disinfecting surfaces on the boats used for the Program.
6. **HAND WASHING & SANITIZING** AYC’s Sail Training Facility does not have washroom facilities that will enable quick access to hand washing. AYC will provide access to hand sanitizer to all participants in the Program. Participants are further encouraged to bring their own hand sanitizer in small containers that can be kept on their person for frequent use throughout each session.
7. **FOOD & EATING** Participants may bring their own food to eat so long as all food is kept in airtight containers and no garbage, utensils, containers or scrap food is left behind. To minimize the amount of surfaces touched by multiple participants, AYC is unable to offer refrigeration or microwaves for participants to heat or cool food that is brought onto AYC property.
